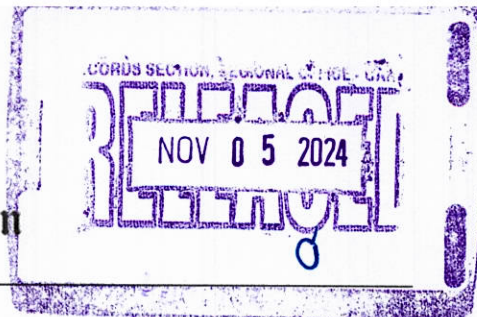

ORIENTATION ON DEPED ORDER NO. 26, S. 2022 (IMPLEMENTING GUIDELINES
OF SCHOOL GOVERNANCE COUNCIL) FOR ELEMENTARY SCHOOL HEADS

1. This Office, through the Field Technical Assistance Division (FTAD), will conduct an Orientation on DepEd Order No. 26, s. 2022 (*Implementing Guidelines of School Governance Council*) for Elementary School Heads on November 18-19, 2024, at NEAP, DepEd Regional Office.

2. This orientation aims to equip participants with the necessary knowledge, skills, and attitude regarding the School Governance Council. Specifically, participants are expected to:

- Organize or reorganize and rename the School Governing Council to School Governance Council.
- Implement DepEd Order No. 26, s. 2022 (*Implementing Guidelines on the Establishment of School Governance Council*) beginning the next School Year.
- Share the training content with other school heads in their respective Schools Division Office.
- Appreciate the value of shared governance and feedback mechanism
