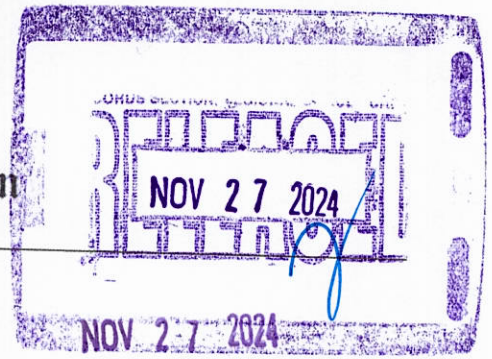

PARTICIPATION TO CVIF-DYNAMIC LEARNING PROGRAM (DLP) ONBOARDING

1. In line with Section 3 of RA 9155, which empowers the DepEd to adopt innovative delivery modes, such as distance learning, modular learning, and other alternative modes, to ensure that all Filipino children receive education despite geographical, economic, or social challenges and in consonance to **DepEd Order No. 12, s. 2020** which formalizes Alternative Delivery Modes (ADM) to ensure continuity in education even during emergencies, the DepEd Caraga Region, through the Curriculum and Learning Management Division (CLMD), will be adopting the Dynamic Learning Program as part of the **Flexible Learning Options-Alternative Delivery Modalities (FLO-ADM)** to ensure learning continuity during emergencies.
