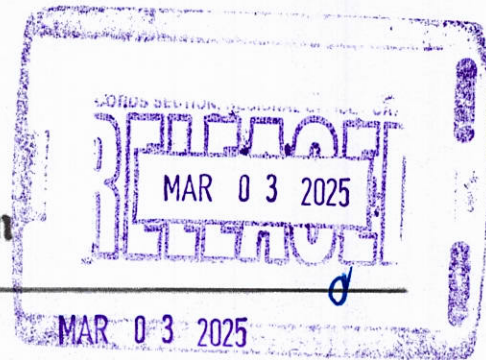

CONDUCT OF REGIONAL MONITORING OF PRIVATE SCHOOLS PARTICIPATING
IN THE GOVERNMENT ASSISTANCE AND SUBSIDIES (GAS)
PROGRAMS IN BUTUAN CITY

1. With reference to Regional Memorandum No. 1343, s. 2024, titled *Monitoring of Private Schools Participating in the Government Assistance and Subsidies (GAS) Programs*, this Office informs the Schools Division Office of Butuan City about the scheduled monitoring of private schools participating in the GAS programs on March 3-7, 2025.
