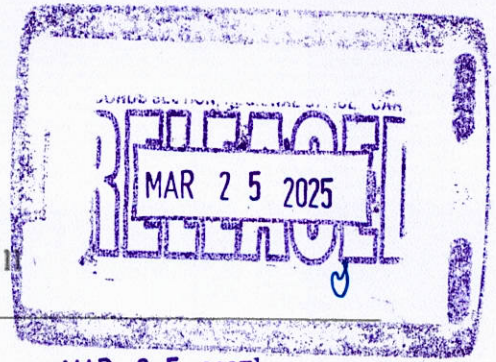

CONDUCT OF MONITORING AND EVALUATION CAPACITY BUILDING (M&E CAPB)
PHASES 3 AND 4 RE: DATA ANALYSIS, AND INFORMATION DISSEMINATION,
REPORTING AND UTILIZATION

1. In accordance with D.O. No. 29, s. 2022, the Department of Education (DepEd) issues the **Adoption of the Basic Education Monitoring and Evaluation Framework (BEMEF)** to guide DepEd operating units across governance levels in conducting Monitoring and Evaluation (M&E). This policy supports the Department's global and national commitments to delivering basic education in the country, aligned with the **Basic Education Development Plan (BEDP) 2030**.

2. The M&E framework comprises four (4) core processes:
Phase 1: Basic Concepts on M&E and Theory of Change (ToC)
Phase 2: Data Collection and Management
Phase 3: Data Analysis
Phase 4: M&E Results Dissemination and Reporting

In 2021, Phase 1 of the M&E Capacity Building (CapB) was conducted, during which participants developed the ToC for a specific DepEd program or policy and finalized indicators for measurement. In 2023, Phase 2 was implemented, enabling DepEd M&E personnel and/or program owners to determine appropriate data collection and management mechanisms for their respective tasks.

3. To complete the core processes, this office will conduct **Capacity Building on Phases 3 and 4 on April 23-25, 2025**, at **NEAP Silver Hall, DepEd Caraga Regional Office**.

4. This activity aims to:
a. Apply data analysis method to convert the collected raw data into usable information;
b. Develop effective strategies in disseminating results to key stakeholders; and
c. Identify challenges, evaluate program effectiveness, and propose solutions for program improvement.
