**STAKEHOLDERS CONVERGENCE MEETING FOR INTEGRATED
SCHOOL HEALTH AND NUTRITION PROGRAMS**

1. The Department of Education Caraga Regional Office will be holding a Stakeholders Convergence Meeting for Integrated School Health and Nutrition Programs on September 2, 2025, at Nickel Hall, R-NEAP, Teacher Development Center, Butuan City, from 9:00 a.m. to 5:00 p.m.
