The Department of Education-Caraga Region, through the 2024 General Appropriations Act (GAA) intends to apply the sum of Three Million Eight Hundred Ninety Thousand Six Hundred Ninety-Three Pesos and Forty-Nine Centavos (₱3,890,693.49) being the Approved Budget for the Contract (ABC) to payments under the contract for the Procurement for the Completion of the Repairs at NEAP Building (Rebidding) with Project Identification No. 2025-09-511. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The DepED Caraga Regional Office, through its Bids and Awards Committee (BAC) now invites bids for the above Procurement Project. Completion of the Works is required 150 calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

4. Interested bidders may obtain further information from Department of Education, Caraga Regional Office, Procurement Unit and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM, Mondays to Fridays.

5. A complete set of Bidding Documents may be acquired by interested bidders starting October 24, 2025 to November 14, 2025, 8:00 AM to 5:00 PM, from the given address and website(s) below and upon accomplishing the bidder's information sheet and payment of the applicable fee for the Bidding Documents to the DepEd Caraga Regional Office Cashier, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.
6. The Department of Education, Caraga Regional Office will hold a Pre-Bidding Conference through face to face modality on November 5, 2025, 9:00 AM at the Gold Hall, DepEd Caraga Regional Office, J. Rosales Ave., Butuan City.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before 8:59 AM of November 17, 2025. Late bids shall not be accepted.
8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 16.
9. Bid opening shall be on November 17, 2025, 9:00 AM at the Gold Hall, DepEd Caraga Regional Office, J. Rosales Ave., Butuan City, or in case of change of venue, the bidders will be informed accordingly. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.
- A maximum of two personnel per bidder is allowed, prospective Suppliers should present their identification cards before the start of the bid opening and in case of representatives, they must present a duly notarized Special Power of Attorney (SPA) which contain express authorization to represent the bidder/proprietor. Any representation which does not comply with the foregoing conditions shall not be recognized and has no legal standing to represent his/her employer. Personnel who has no business at all during the bid opening shall not be authorized to participate or enter the venue for the bid opening.
- For the purpose of constituting a quorum, both the physical and virtual presence of the BAC members shall be considered pursuant to GPPB Resolution No. 09-2020..
10. Only duly authorized representatives with Letter of Intent and Special Power of Attorney are allowed to purchase and drop the bidding documents. Certificate of PhilGEPS Platinum Registration is also required.
11. The DepEd Caraga Regional Office reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
