**SUBMISSION OF REFERENCE DATA ON TEACHERS TEACHING GMRC AND/OR
VALUES EDUCATION FOR THE NATIONAL BASELINE STUDY**

Pursuant to DM-LS-2025-209, titled *"Participation in the Online Teacher Survey, Focus Group Discussions, and Field Validation Activities for the National Baseline Study on Good Manners and Right Conduct (GMRC) and Values Education (VE) Implementation,"* and in reference to the attached Advisory dated January 9, 2026, the Bureau of Learning Delivery (BLD) requests the submission of the **number of teachers** currently teaching **GMRC and/or VE** in your respective divisions.

 - Deadline for submission to the Regional Office: **January 20, 2026**.

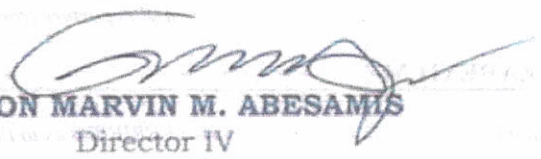
