**THIRD ROUND OF VALIDATION OF BILLETING QUARTERS FOR PALARONG
PAMBANSA 2026**

1. To ensure the optimal readiness of accommodations for Palarong Pambansa 2026, this Office hereby announces the conduct of the Third Round of Validation of all identified Billeting Quarters on March 2-3, 2026.

2. Unlike the initial assessment, this activity will concentrate on verifying the implementation of the corrective measures recommended during the second visit. The validation teams will review the progress of infrastructure enhancements to determine whether the facilities now fully meet the established standards.

1. To promote objectivity and provide a fresh perspective on the inspection of results, changes have been made to the assignment of validating teams. While the composition of the personnel remains the same, the teams will now conduct a cross-validation of billeting quarters different from their initial assignment.
