BAGONG PILIPINAS SERBISYO FAIR

1. In accordance with the DepEd Memorandum dated 3 March 2026 from the Office of the Secretary, and in line with the directive of President Ferdinand Marcos Jr., Region XIII (Caraga) hereby identifies **Butuan Central School-Based Community Learning Center (BCS-CLC)** as a lead pilot implementer for the **Bagong Pilipinas Serbisyo Fair (BPSF)**. This initiative aims to provide a "One-Stop Shop" to facilitate the school-to-work transition for ALS learners.

2. The program aims to provide qualified ALS learners, particularly first-time jobseekers, with:

- **Free issuance** of required pre-employment documents (NBI, Police Clearance, PhilHealth, etc.) pursuant to R.A. No. 11261.
- Direct access to potential employers through a localized **Job Fair**.
- Technical assistance in accomplishing the **National Skills Registration Program (NSRP)**.
- Participants Technical assistance in accomplishing the **National Skills Registration Program (NSRP)**.

3. **Specific Instructions for Butuan Central Elementary School-CLC** as the lead implementer, the BCES-CLC is directed to execute the following:

- **Learner Profiling:**
Identify all qualified ALS learners (graduating or recently completed) who are "First-Time Jobseekers."
- **NSRP Compliance:**
Ensure all identified learners accurately accomplish the National Skills Registration Program (NSRP) forms.
 - *Deadline for submission to Division Office: 6 March 2026* (to meet the Regional deadline of 9 March).
- **Barangay Coordination:** Coordinate with the local Barangay Council to facilitate the issuance of the **First-Time Jobseeker Certification**, a mandatory requirement for free document processing.
- **Venue Preparation:** Prepare a designated area within the CLC for the "One-Stop Shop" services and employer interviews scheduled for the nationwide rollout on **25 March 2026**.

4. **Roles of the Division Office (BUTUAN City):**

The Schools Division Office (SDO) shall:

- Provide technical assistance to BCES-CLC in consolidating NSRP data.
- Coordinate with the Regional Office for the deployment of partner agencies (DOLE, PSA, NBI, etc.) on the day of the fair.
- Monitor and evaluate the pilot implementation to serve as a model for other CLCs in Caraga.

In line with the directive of President Ferdinand Marcos Jr. to strengthen employment pathways and bring government services closer to the people, and consistent with the Department of Education's commitment to improving school-to-work transition, DepEd will implement a One-Stop Shop for Senior High School-Technical-Vocational-Livelihood and Alternative Learning System learners under the **Bagong Pilipinas Serbisyo Fair**.

This one-day pre-graduation initiative, in partnership with the Department of Labor and Employment (DOLE) and other relevant government agencies, will provide Grade 12 SHS-TVL and qualified ALS learners, particularly first-time jobseekers, with free issuance of required pre-employment documents, pursuant to the First Time Jobseekers Assistance Act (Republic Act No. 11261). It will also feature a job fair to connect learners directly with potential employers.

The pilot will be conducted on **13 March 2026** in selected public schools and learning centers in Region V (Sorsogon Province), Region VII (Talisay City), and Region XI (Panabo City), as listed in **Annex A**. A nationwide rollout will follow on **25 March 2026**.

All concerned offices are directed to submit the National Skills Registration Program (NSRP) forms on the following dates:

- 3 March 2026 – Pilot schools
- 9 March 2026 – Nationwide

Regional Directors shall coordinate with the concerned Schools Division Offices and participating schools and learning centers to ensure readiness and proper implementation.
