The granting of honoraria is subject to the approval of the **Regional Director** and must strictly adhere to applicable budgeting, accounting, auditing, and procurement policies.

5. Participants and RTWG members attending activities on weekends or holidays are entitled to Service Credit (SC) or Compensatory Time-Off (CTO), in accordance with DepEd Order 53, s. 2003.
