SUBJECT : ADMINISTERING THE ONLINE-CAREER EXECUTIVE SERVICE PERFORMANCE EVALUATION SYSTEM (CESPES) FOR CY 2018 USING THE GUIDELINES PRESCRIBED UNDER CESB RESOLUTION NO. 1136

The Career Executive Service Board (CESB), through Resolution No. 1445 dated 25 January 2019 has adopted the guidelines on "Strengthening Performance Accountability through the Enhanced Career Executive Service Performance Evaluation System" for officials in the Career Executive Service (CES).

The revised CESPES Guidelines and Tools shall be used beginning Performance Year 2019. Meanwhile, the prescribed forms and guidelines under CESB Resolution No. 1136 shall remain in effect for Performance Year 2018.

Agencies are advised that the period for the accomplishment of ratings for the two semesters of CY 2018 Online CESPES shall commence on **11 March 2019** and must be completed on or before **26 April 2019**. The following is the detailed schedule:
