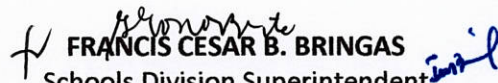

2019 REGIONAL MID-YEAR PROGRAM IMPLEMENTATION REVIEW (PIR) OF THE INDIGENOUS PEOPLES EDUCATION (IPEd) PROGRAM

TO: SCHOOLS DIVISION SUPERINTENDENTS
This Region
