**REGIONAL TRAINING ON THE UNIVERSAL PREVENTION CURRICULUM FOR SUBSTANCE USE
(CURRICULUM 2: PHYSIOLOGY AND PHARMACOLOGY FOR PREVENTION SPECIALISTS)**

**TO: Schools Division Superintendents
Chiefs, CID and SGOD
Division NDEP Coordinators**

1. In line with the National Drug Education Program (NDEP) of the School Health Division of the Bureau of Learner Support Services Division (SHD-BLSS), the Regional Training on the Universal Prevention Curriculum for Substance Use (Curriculum 2: Physiology and Pharmacology for Prevention Specialists) will be conducted on October 28-31, 2019 at a venue to be announced later.
2. The objectives of the training are to:
 - a. discuss the physiology and pharmacology of substance use and abuse;
 - b. provide NDEP coordinators and other focal persons a deeper understanding on the mechanism of substance use to body processes;
 - c. formulate action plans for implementation of prevention programs; and
 - d. update and continue the training of prevention specialists on different settings and global trends.
3. The participants to this training are the participants from the twelve (12) Divisions of the Curriculum 1 of the Regional Training on the Universal Prevention Curriculum held last August 28-30, 2018 at Inland Resort Hotel and October 3-6, 2018 at Grand Palace, Hotel both at Butuan City respectively. 4. Participants are expected to be at the training venue on Day One (October 28) at 1:00 pm for registration. The training shall start promptly at 2:00 PM. Check-out shall be at 12:00 noon of Day Four (October 31). Meals shall be provided to all participants for duration of the training, from lunch on Day One to the Breakfast on the Day Four.
5. Travel expenses of the participants shall be covered by the funds downloaded to Caraga Region through the Sub-Allotment release Orders (sub-AROs) dated May 2, 2019, then the said fund will be transferred at respective division offices subject to the existing accounting and auditing rules and regulations.
