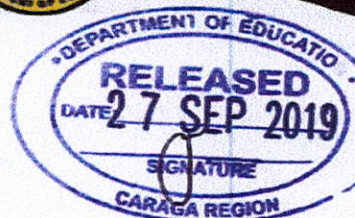

Our organization has been implementing intensive education and prevention through awareness raising and capacity building on anti-trafficking in persons since 2010 in Caraga region. Currently, we are implementing the KKS-Cinemobile Phase 4 in Surigao City, Municipalities of General Luna, Socorro and Claver in the province of Surigao del Norte.

JPIC-IDC, Inc. through its KKS-Cinemobile Phase 4 Project aims to contribute to the reduction of human trafficking for sexual exploitation of children and women by providing competency enhancement training for the prosecutors, law enforcement, intensified advocacy activities as well as installing mechanisms by the communities to proactively combat trafficking in persons.

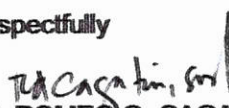
