1. The Information and Communication Technology Unit (ICTU) will conduct a 3-day Training-Workshop on the Use and Curation of Open Educational Resources through DepEd Computerization Program (DCP) and Capacity Building for OER Trainers on October 29-31, 2019 at Almont Inland Resort, Butuan City.

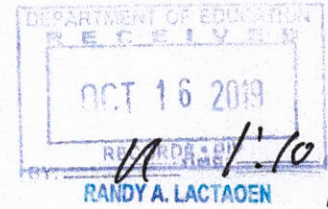

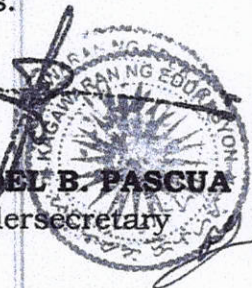
