This Region

1. The field is hereby informed on the approval of the issuance of Government Permit to Operate and Certificate of Compliance for School Year 2019-2020 in the division of Agusan Del Norte, Agusan del Sur, Butuan City and Siargao Islands.
2. Private school principal/administrator is advised to display the aforementioned government permit to operate/ certificate of compliance permit in conspicuous places of the school.
3. The Government permit to operate which is temporary in nature and should be renewed on or before August 30 of every year preceding the start of the school year when the school/new course is supposed to operate. On the other hand, government recognition for each year level or course shall be for an indefinite period provided that the requirements of law, rules and standards will be satisfies. (D.O. No. 88, s. 2010, Section 29-30).
