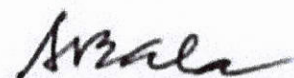
**SUBJECT : ONLINE CAREER EXECUTIVE SERVICE PERFORMANCE

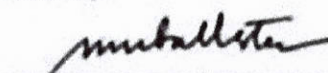
