**ORIENTATION ON THE POLICY GUIDELINES ON THE ADOPTION OF THE K TO 12
TRANSITION CURRICULUM FRAMEWORK FOR LEARNERS WITH DISABILITIES**

1. The Department of Education (DepEd) recently released DepEd Order No. 021, s. 2020 entitled Policy Guidelines on the Adoption of the K to 12 Transition Curriculum Framework for Learners with Disabilities (LWDs) to be used nationwide by Special Education field implementers.
