**ORIENTATION ON EMERGING PARTNERSHIPS
ON SCHOOL DENTAL HEALTH CARE PROGRAM**

1. The Department of Education Caraga Region through the Education Support Services Division Health Unit shall conduct a blended orientation on the School Dental Health Care Program – SDHCP with Partners on December 7, 2020 at 1:00 to 6:00 o'clock in the afternoon.
2. The specific objectives of this blended undertaking are the following:
 - a. To understand the geographical parameters, scope of coverage and ratio of Dentists against the learners and DepEd personnel in all the SDOs of Caraga region;
 - b. To accomplish the individual health record in charting as significantly needed in establishing an appropriate data that is relevant to the learners' basic education information system – BEIS;
 - c. To come up with a deployment and scheduling agreement for every SDOs in coordination with DOH and other partners; and
 - d. To gain support and commitment among the external participants through Memorandum of Understanding among partners.
3. Participants to this activity are the regional office program management team, all Division Dentists, Dentists from the DOH Regional Office, Government lined agencies (NCIP, PNP and Philippine Army), LGUs from the Provincial, City and Municipal Health Offices of the region, Hospital Dentists, Regional Coordinator and Chapter Presidents of the Philippine Dental Association Caraga Region.
