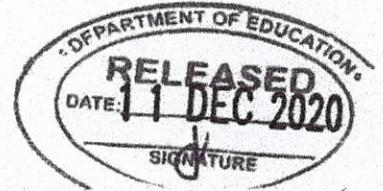

**TWO-DAY VALIDATION AND MONITORING WORKSHOP ON LIS/EBEIS
CONCERNS CUM YEAREND ACTIVITY CY 2020**

1. The Covid 19 pandemic has greatly affected the monitoring of LIS/EBEIS important issues in schools both in the elementary and secondary levels. This curtailed the face to face activities supposed to be done in our public and private schools.
2. Anent this, there will be a Two-Day Monitoring and Validation activities on LIS/EBEIS concerns of the twelve (12) Schools Division Offices to be represented by the Division Planning Officers and SEPS and two (2) QAD Staff from the Regional Office. This is tentatively set on December 28-29, 2020 of which the venue has to be determined later.
3. This activity aims to:
 - a. revisit the provisions of DepEd Order No. 32, series 2018 and its coverage
 - b. resolve issues on LIS/EBEIS arising in schools
 - c. create Flow charts in the submission of various Planning Reports from the Schools Division Offices to the Regional Office
 - d. come up with an agreement on processes which can only be exercised by DepEd Caraga Regional Office through the Policy, Planning and Research Division.
4. Participants to this activity are: PPRD Chief and Staff (7), two (2) QAD Staff, RD/ARD, Division Planning Officers (12) and Senior Education Program Specialist in SGOD
5. The two-day activity will start at 8:00AM on December 28, 2020 and will end on December 29, 2020. There will be no Day 0. Participants may claim for their board and lodging on December 27 charged to their local funds. Room accommodation will only be in the evening of December 28, 2020. First meal will be breakfast on December 28, 2020 and last meal will be dinner of December 29, 2020.

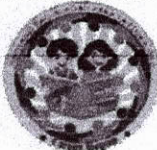
