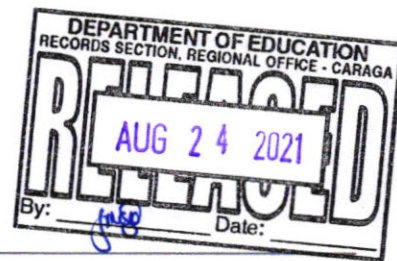

- 1) develop print and non-print prototype supplementary materials on the different concepts of GMRC that can be used as aid in the delivery of the curriculum;
- 2) revisit the 1997 Revised Version of the DECS Values Education Program (VEP) vis-à-vis the GMRC and Values Education Act;
- 3) improve the existing VEP by incorporating the relevant provisions of Republic Act No. 11476; and
- 4) come-up with proposal for the enhancement of the VEP with focus on learning delivery that is responsive to the current situation and needs of the Filipino learners.

1 Regional EsP (GMRC & Values Education) Supervisor or his/her alternate	• Oversees the process of development of print and non-print supplementary materials from pre-work activity up to the final phase. • Provides inputs and technical assistance to the development team especially on the content of the materials.
1 Writer - elementary teacher with at least 3 years of experience in teaching EsP	• Discusses with the development team the design and format of the content (script, sequence guide, etc.) for the print and non-print supplementary materials. • Writes content for the storyboard/script based on the assigned values. • Ensures that the content is free from factual, grammatical, and typographical errors, and prejudicial and plagiarized content and visual images. • Follows the DepEd standards and guidelines in the development of the content. • Ensures that text and images follow the social content guidelines of DepEd. • Conducts revision of written content based on the suggestions of the reviewers and resource persons.
1 Illustrator	• Consults and agree with the development team on the visuals needed for the print supplementary materials to be developed according to DepEd standards. • Illustrates scenes explaining the story/text through visuals.
1 Computer/digital media illustrator	• Consults and agree with the development team on the visuals needed for the non-print supplementary materials to be developed according to DepEd standards. • Illustrates scenes explaining the story/text through visuals.

1 Lay-out artist	• Renders layout pages and artwork. • Executes revisions, if needed.
1 Animator	• Consults and agree with the development team on the visuals needed in the supplementary materials. • Provides visuals according to DepEd standards. • Translates the visual representations of the materials into animation, video, or movie format. • Enhances the visuals, sounds, and materials design by using various media formats. • Designs models, backgrounds, sets, characters, objects, and animation environment • Develops model and graphics animations.
1 Graphic designer	• Conceptualizes the design of the materials. • Supervises work of lay-out artist.
1 Photo editor	• Conducts photo research for possible usable stocks. • Conducts photo shoot, if needed and if possible. • Conducts photo editing. • Conducts photo production for layout purposes.
1 Video editor	• Discusses the narrative structure and story goals with the rest of the development and production team. • Manages and oversees all technical aspects of video recording and editing. • Takes charge of the industry level editing and assembling recorded raw material into suitable, finished product ready for use. • Creates sound effects by recording specific audio clips or choose audio effects from a database of sounds to include in the final product.
