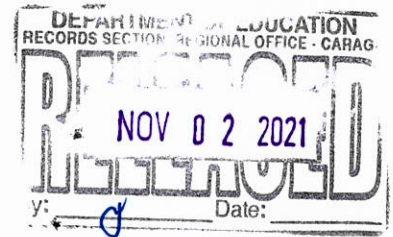

This pertains to the Memorandum sent by my Office last 12 October 2021 requesting for assistance in the validation of teacher participants in the *Professional Development Program on Assessment and Emerging Literacies with focus on PISA* (Assessment PD).

We would first like to take this opportunity to thank you and your staff for your kind assistance in the engagement of teachers during this validation process. There are now roughly 19,781 teacher participants registered in the program, and we have been able to conduct the launch the Assessment PD last October 23, 2021.

Prior to officially enrolling them in the Learning Management System (LMS), we hope to request for the assistance of the Assessment PD focal persons of the Regional Offices (ROs) and Schools Division Offices (SDOs) within your jurisdiction to please review and correct the data of registered participants. Instructions on the data correction process are attached as **Annex A**.

Data corrections will only be accommodated until **12pm of October 30, 2021 (Saturday)**. This would entail that the participants who have not received communications regarding the first synchronous lecture on the same day due to

errors in their data will eventually have to take the activities for the day in an asynchronous manner, through the recorded lecture.

3. Due to the current volume of participants and other relevant considerations, we will no longer be able to accommodate **requests for replacements and**

**additional participants.** If there are participants who will be unable to attend to the course due to medical concerns (e.g., sickness, maternity leave, etc.) and other personal reasons, they may drop out of the course, but their slot will be forfeited and can no longer be taken by another teacher from the same division.

We acknowledge that this is inconsistent with previous communication that we have given within the past few days; however, the program management has decided that this policy will now have to be implemented to avoid further delays in the enrollment process.
