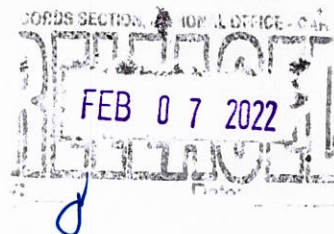

RENAMING OF SENIOR HIGH SCHOOL FOR ISSUANCE OF UACS CODE

1. This is to inform the field that the Department of Budget and Management (DBM) is currently finalizing the list of schools for inclusion in the National Expenditure Program (NEP) 2022. Thus, it requested the Department of Education to submit the new name and legal basis of the identified Stand-Alone Senior High Schools which need to be renamed for issuance of UACS Code.

2. The identified Stand-Alone Senior High Schools are the following:

| Division         | School ID | School Name                     | Curricular Offering Classification |
|------------------|-----------|---------------------------------|------------------------------------|
| Agusan del Norte | 340204    | SHS in Carmen, Agusan del Norte | Purely SHS                         |
| Bislig City      | 340306    | Stand Alone Senior High School  | Purely SHS                         |

3. In DepEd Order No. 40, s. 2014, Section A.5, Item 1, Section 99 (d) of Republic Act No. 7160 (Local Government Code of 1991) which authorizes the Local Sanggunian to change the name of schools through an ordinance, with the Local School Board as recommending body.

4. Moreover, in DepEd Order No. 051, s. 2015, Section A.4, Item 1, the naming of stand-alone SHSs shall be consistent with the provisions of DepEd Order No. 29, s. 2011 entitled "Revised Guidelines on the Naming and Renaming of Schools"; provided, that it shall bear the words "Senior High School" (e.g. Manila Senior High School).

5. The SDO shall submit an original copy of the approved Sanggunian Ordinance renaming the Stand-Alone Senior High School. Thus, the Regional Office through Quality Assurance Division will re-issue approval to operate to be approved by the
