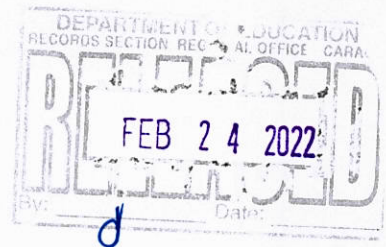

This is to respectfully request for the issuance of Sub-Allotment Release Order (Sub-ARO) to the identified Schools Division Offices (SDOs) of Caraga Region from the fund downloaded by the Bureau of Learning Resources (BLR) amounting to **21,474,940.00 with Sub-ARO No. OSEC-13-22-0591**.
