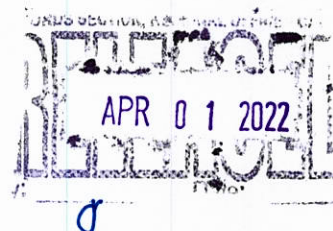

 - 1.8. Pictures of the SPED Classroom to be converted into ILRC Support service area;
 - 1.3. Engagement from the LGU or NGO that support the development and welfare of learners with disabilities (MOU/MOA, Certification, etc.); and
 - 1.4. Enrollment of LWDS per exceptionalities.
2. All provisions in the Regional Memorandum No. 0229 s. 2022 dated March 22, 2022 are still in effect.
