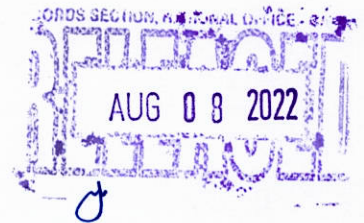

- d. Organization
 - i. Natatanging Bulawanong Sulô
- 4. The Division PRAISE Committee shall endorse one nominee for each category to the Regional Office not later than **September 1, 2022**.
- 5. Nominees shall submit **1 long folder** containing all the required and supporting documents and be properly indorsed to the Regional Office. With the following nomination documents in A4 size bond paper:
 - a. Indorsement from SDS
 - b. Nomination Form and Write Up (in Font 11 Bookman Old Style)
 - c. Omnibus Certification of Authenticity and Veracity of Documents (duly notarized)
 - d. Updated Service Records
 - e. Personnel Data Sheet (CSC Form 212)
 - f. Certificate of No Pending Case
 - g. IPCRF/OPCRF for the last 3 rating periods
 - h. Rating Sheet for Professionalism and Personal Characteristics
 - i. Certificates and other supporting documents (MOVs required in the nominated category) arranged and labeled per criterion.
- 6. Scanned copy of the contents of the submitted folder (in exact arrangement and in one pdf file labeled as Division_Lastname,Firstname) shall also be submitted via online at **<https://bit.ly/DepEd13BSA2022>** by the Division Rewards and Recognition Focal Person.
- 7. All submitted documents shall be pre-evaluated by PRAISE Secretariat on the compliance and completeness of the submitted documentary requirements. Non-compliance with the submission of complete documentary requirements and policies, including those pertaining to the deadline, size and number of folders, accuracy and completeness of information required in the nomination form and for a maximum number of pages for the accomplishment write-up, clearances, and other required documents, shall render the nominee ineligible for the Search. Nominations with incomplete documents shall no longer be processed.
- 8. An official list of nominees shall be released through a regional bulletin by this office.
- 9. Refer to **Regional Order No. 001, s. 2022**, for the guidelines and criteria of the awards mentioned above.
