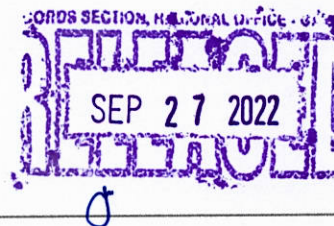

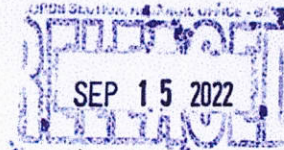

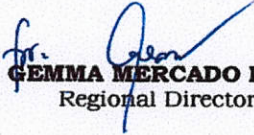

REGIONAL ONLINE ORIENTATION TO SCHOOL HEADS ON THE SPED
IMPLEMENTATION, THE USED OF FILIPINO SIGN LANGUAGE (FSL)
AND THE CREATION OF INCLUSIVE LEARNING
RESOURCE CENTERS

1. The Department of Education, Caraga region, through the Curriculum and Learning Management Division (CLMD) shall conduct a Regional Online Orientation to School Heads on the SPED Implementation, the use of Filipino Sign Language (FSL) and the Creation of Inclusive Learning Resource Centers on September 30, 2022 via this link: <https://meet.google.com/izw-dagm-yrr>.
