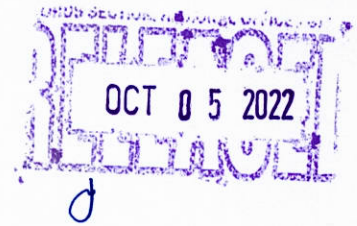

**DESIGNATION OF DATA PROTECTION OFFICERS AND COMPLIANCE
OFFICERS FOR PRIVACY**

To: Undersecretaries
Assistant Secretaries
Bureau and Service Directors
Regional Directors
Schools Division Superintendents
All Others Concerned

1. In the exigencies of the service, and pursuant to the provisions of existing laws, **Atty. Anne Rachel C. Miguel**, Director IV of the Bureau of Human Resource and Organizational Development (BHROD), and **Atty. Rhonan G.L. Orebia**, Director IV of the Legal Service, are designated as the **Data Protection Officer (DPO)** and **Alternate DPO** to oversee the general implementation of Republic Act No. 10173 or the Data Privacy Act (DPA) of 2012, its Implementing Rules and Regulations (IRR), and other relevant National Privacy Commission (NPC) issuances, in the Department.
2. There shall likewise be **Compliance Officer/s for Privacy (COP)** designated in each of the **Regional Offices (ROs)** and **Schools Division Offices (SDOs)**. For the ROs, the Chief Administrative Officer, Administrative Division shall perform the functions of the COP, with the Attorney IV as alternate COP. For SDOs, the Attorney III shall be the COP, with the Division Administrative Officer as alternate COP. The ROs and SDOs shall furnish the DPO and Alternate DPO the names and designations of their COPs.
3. The above functions shall be in addition to the existing duties and responsibilities of the foregoing Department of Education (DepEd) personnel, without additional compensation. The foregoing DepEd personnel are enjoined to observe the relevant laws, rules and regulations to ensure the legality and validity of all acts performed pursuant to this Order.
4. All DepEd personnel concerned shall give full support and cooperation to the foregoing personnel in the exercise of their duties and functions.
5. Immediate dissemination of and strict compliance with this Order is directed.
