INVITATION TO BID FOR Procurement of Meals and Snacks with Venue and Accommodation for the Training-Writershop on the Development, Quality Assurance and Pilot Testing of Regional Achievement Tests on March 1-5, 2023

1. The Department of Education-Caraga Region, through the General Appropriations Act 2023 intends to apply the sum of One Million Three Hundred Sixty-Four Thousand Pesos (P1,364,000.00) being the ABC to payments under the contract for Procurement of Meals and Snacks with Venue and Accommodation for the Training-Writershop on the Development, Quality Assurance and Pilot Testing of Regional Achievement Tests on March 1-5, 2023. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The Department of Education-Caraga Region now invites bids for the above Procurement Project. Delivery of the Goods is required within five (5) calendar days. Bidders should have completed, within Five Years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
 - a. Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the 2016 revised IRR of RA No. 9184.
4. Prospective Bidders may obtain further information from Department of Education-Caraga Region and inspect the Bidding Documents at the address given below from 8:00 AM to 5:00 PM, Monday to Friday.
5. A complete set of Bidding Documents may be acquired by interested Bidders on January 20, 2023, from the given address below upon accomplishing a bidder's information sheet and payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (P5,000.00) to the DepEd-Caraga Cashier. The Department of Education-Caraga Region shall allow the bidder to present its proof of payment for the fees through in person or electronic means.
6. The Department of Education-Caraga Region will hold a Pre-Bid Conference on January 27, 2023, at 9:00 AM at DepEd Caraga Regional Office, RPSU Lobby which will be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address indicated below on or before 8:59 AM of February 8, 2023. Late bids shall not be accepted.
8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on February 8, 2023, at 9:00 AM. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. Only duly authorized representatives are allowed to purchase bidding documents with Letter of Intent and Special Power of Attorney. Certificate of PhilGEPS Platinum Registration is required.

11. The Department of Education-Caraga Region reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
