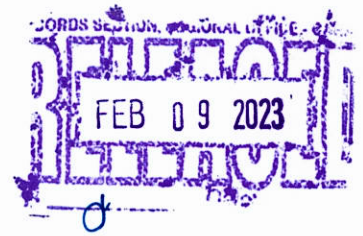

**TWO-DAY VIRTUAL CAPACITY DEVELOPMENT FOR DIVISION CHILD
PROTECTION COORDINATORS AND CPC CHAIRPERSONS**

1. The Child Protection Unit (CPU) is mandated to serve as the lead office in implementing activities, including intervention mechanisms, related to child protection pursuant to DepEd Order 3., s. 2021. With this, the Education Support and Services Division-Child Protection Unit (ESSD-CPU) shall conduct a two-day Virtual Capacity Building for all Child Protection Division Coordinators and Alternate Focal Persons (*preferably those who were not able to attend the Child Protection Specialization Course*) and Child Protection Committee Chairperson in Schools on March 8-9, 2023 via MS Teams: <https://tinyurl.com/2p8nwn8a>
2. This activity primarily aims to equip participants with adequate knowledge and skills and imbued the right attitude toward child protection orientation to discharge their roles and responsibilities accordingly and to appropriately respond and provide protective services to affected children in consonance with the existing protocols of child protection within the school system.
3. Trained Child Protection Specialists on Child Protection Specialization Course are required to assist in the facilitation and shall serve as resource persons in the conduct of this activity.

5. Immediate dissemination and compliance with this Memorandum are desired.
