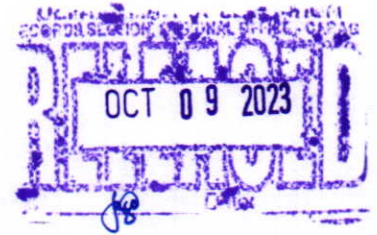

FORMULATION OF RESEARCH-BASED POLICY RECOMMENDATIONS AND
CRAFTING OF POLICY IMPLEMENTATIONS BASED ON RESEARCH
FINDINGS

1. The Office of the Policy, Planning and Research Division (PPRD) is mandated to lead in the gathering an analysis of feedback for policy recommendations submitted to DepEd Central Office and to lead in the review of existing policies and regional implementation guidelines. In line with this, this office will conduct an activity on the formulation of research-based policy recommendations and crafting of policy implementations based on research findings on **November 9-10, 2023** at **RNEAP-Regional Office, Butuan City**.
2. The objectives of the activity are the following:
 - a. to capacitate participants of the policy review process
 - b. to discuss how to distinguish policy problem and policy; implementation challenge based on research results
 - c. to discuss the process of writing policy recommendations
 - d. to utilize research results in the crafting of policy implementation plans
3. The participants of this activity are the School Governance Operations Division (SGOD) Chiefs, Curriculum Implementation Division (CID) Chiefs and Research Coordinators.
4. Research Coordinators shall bring copies of research results subsidized by other funds and results of monitoring and evaluation.
5. The activity is **live-out**. Meals (breakfast, lunch & dinner) and snacks will be served.



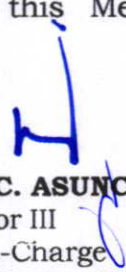
