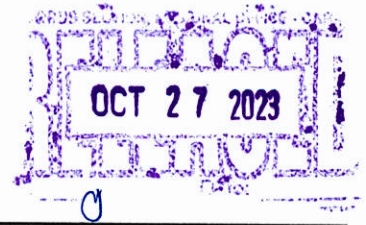

TRAINING OF TRAINERS FOR CHILD PROTECTION COMMITTEE FUNCTIONALITY

3. As such, DepEd ensures the organization of the Child Protection Committees and strengthens its functionality as articulated in DepEd Order No. 40, s. 2012 Re: Child Protection Policy.
