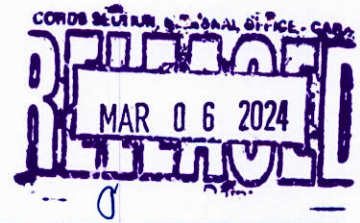

**REORIENTATION/ SEMINAR-WORKSHOP ON THE MAGNA CARTA OF WOMEN
AND OTHER GAD-RELATED POLICIES, REPORTS, AND FORMS**

1. The Philippine Commission on Women (PCW) spearheads the annual National Women's Month Celebration (NWMC) dedicated to recognizing women and their invaluable contributions to nation-building. Emphasizing the imperative to safeguard, advocate for, and uphold women's rights, the NWMC aims to empower women to unleash their full potential and well-being, positioning them as active contributors to the nation's progress.

2. This annual event aligns with the global observance of International Women's Day (IWD).

3. The following issuances serve as the legal bases for the NWMC:

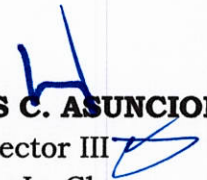
- Proclamation No. 224, s. of 1988, declaring the first week of March each year as Women's Week and March 8 as Women's Rights and International Peace Day;
- Memo Circular 2024-2 titled " Guide for the 2024 Women's Month Celebration"

4. As part of this month's celebration, DepEd Caraga shall conduct a Reorientation/ Seminar-Workshop on Magna Carta of Women and other GAD-Related Policies, Reports and Forms for DepED RO GAD Focal Point System Members and their alternate members and Division GAD coordinators on March 25-27, 2024 in Surigao del Sur.

5. Bislig City and Surigao del Sur shall assist the Regional Office in the logistics for the conduct of the said activity.

6. Members of the Technical Working Group are expected to be at the venue on day zero, March 24, 2024, for the pre-work conference. However, dinner and accommodation shall be made available for all participants on day zero.

7. Activity proper shall commence on March 25 to March 27, 2024. Lunch on March 27, 2024, shall be the last meal covered.
8. All participants are required to bring their laptops and extension wire during the whole duration of the seminar/workshop. GAD Plan and Budget 2024 and GAD Accomplishment Report 2023 are "must bring" documents. They are also enjoined to bring any purple shirt/top to be worn during the closing ceremony.
9. Travel expenses incurred by the participants shall be charged to local GAA-GAD funds of their respective Offices subject to the accounting rules and regulations.
