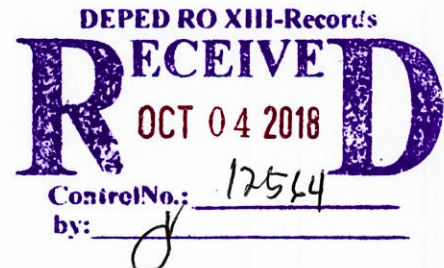

Greetings of Peace!

This has reference to the appointment of the undersigned as the Presidential Adviser for IP Concerns effective 18 April 2018; and the creation of a National Task Force (pending approval of an E.O.) to address core and peripheral issues of the different sectors including the IPs/ICCs.

In this regard, this office in coordination with the AFP thru OJ3, AFP, will be conducting a **Four (4) days Planning Workshop on IP Convergence** which will be attended by the 4th Infantry Division, PA, Commander, TRIAD/Staff down to Brigade Commander, TRIAD/Staff and Battalion Commander, TRIAD/Staff, PNP Officers/Staff, National Intelligence Coordinating Agency (NICA) and National Government Agencies (NGAs) on **October 9-12, 2018 the venue will be announced later.** There are also IP leaders from Regions 10 & 13 who will be attended the Planning Workshop to provide inputs and insights during the discussions/workshops.

The Four (4) day planning workshop will enable the participants to:

1. Empathize with the ICC/IP Struggle, realizing their importance to national security;
2. Use knowledge about the current operational environment in identifying approaches to address IPs/ICCs concerns;

3. Identify the role and develop agency specific strategies, programs and activities to address IPs/ICCs concerns; and,
4. Integrate and harmonize approaches and strategies into the overall convergence effort to protect and promote the interest of IP/ICCs.

With this regard, we request from your good office **four (4) representatives**, preferably **planning officers** to join the entire activity in order to come-up with a new operational methodology and approaches (Unify, Capacitate, and Empower) and action plan to be applied for convergence in the IPs/ICCs thru Whole-of- Nation Approach and inter-agency collaboration and coordination.

Furthermore, we also request your participants to prepare a **Short Presentation** of your programs/projects for the IPs/ICCs as one of the bases for discussion during planning workshop.
