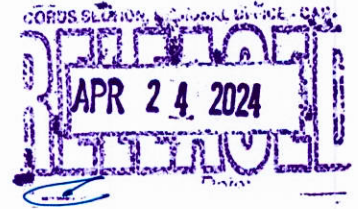

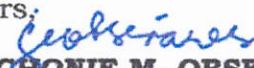
Madam:

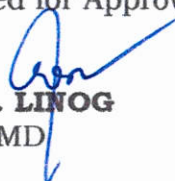

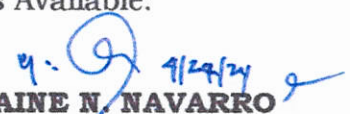
