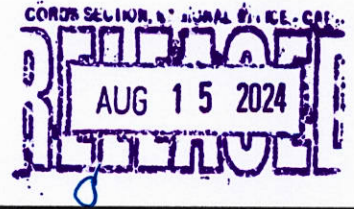

**REGIONAL PROGRAM IMPLEMENTATION REVIEW ON THE SCHOOL MENTAL
