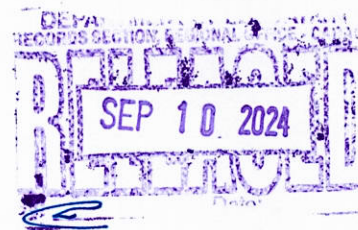

SUBMISSION OF REPORTS ON THE IMPLEMENTATION OF MADRASAH
EDUCATION PROGRAM (MEP) FOR CY 2024

1. DepEd Order No. 41, s. 2017 (*Policy Guidelines on the Implementation of Madrasah Education in the K to 12 Basic Education Program*), DepEd Order No. 11, s. 2024 (*Amendment to DepEd Order No. 25, s. 2021, Revised Implementing Guidelines on the Utilization of Funds for the Madrasah Education Program*), and DepEd Order No. 25, s. 2021 (*Revised Implementing Guidelines on the Utilization of Funds for the Madrasah Education Program*) collectively outline the policies and guidelines necessary for the full implementation and achievement of the program's objectives.
2. In preparation for the upcoming Program Implementation Review, to be conducted by the Bureau of Learning Delivery-Student Inclusion Division (BLD-SID) from September 18-20, 2024 in Davao City, Schools Division Offices implementing the program are required to submit the following signed reports: Approved Work and Financial Plan, Quarterly Physical and Financial Accomplishment Reports (Q1 and Q2), Enrollment Report (disaggregated by sex, grade level, and school), Profile of Implementing Schools, List of ALIVE Teachers, Inventory of Division-Contextualized Learning Resources, and Program Implementation Issues and Concerns. All Division MEP Coordinators (DMEPCs) are required to prepare and submit the necessary reports to the Regional Office through the Curriculum and Learning Management Division (CLMD) via email at clmd_caraga@deped.gov.ph. Please also send a copy of the reports to the Regional MEP Coordinator (RMEPC), Rhea J. Yparraguirre, at rhea.yparraguirre@deped.gov.ph. The deadline for submission is Friday, September 13, 2024.
