1. With reference to DM-CI 2018 -00444, the Department of Education through the Bureau of Curriculum Development shall conduct the Training on the Enhanced Special Program in Journalism ( SPJ) on November 14-16, 2018 at Boy Scouts of the Philippines International Hotel, Makiling Los Baños, Laguna.
