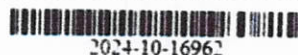

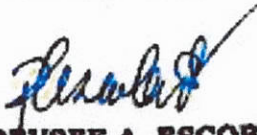

The Learner Rights and Protection Office (LRPO) is mandated to serve as the lead Office of DepEd in implementing programs, projects, and activities, including intervention mechanisms, relative to learner rights and protection at different governance levels of the Department of Education. Additionally, it is tasked with establishing functional Learner Rights and Protection Committees (LRPCs) in schools.¹

In relation thereto, the LRPO will conduct the "Training on Learner Rights and Protection Committees (LRPCs)." The training aims to establish and strengthen LRPCs in schools, ensuring they are fully functional and effective in safeguarding learner rights. At the end of the training, the participants should be able to gain the necessary knowledge and skills to implement policies and practices that protect and empower learners, creating a safer and more supportive learning environment.

In view of the foregoing, Office of the Undersecretary for Operations through the LRPO, hereby requests the attendance of 90 members from Learner Rights and Protection Committees in schools who have not yet undergone any Child Protection Committee or Learner Rights and Protection Committee Trainings.
