16th NATIONAL CONGRESS AND SEMINAR-WORKSHOP OF THE DEPARTMENT
OF EDUCATION-NATIONAL EMPLOYEES UNION

1. Pursuant to DepEd Memorandum DM-OUHROD-2024 No. 1971, s. 2024 dated September 30, 2024, the Department of Education will conduct its *16th National Congress and Seminar Workshop of the Department of Education-National Employees Union* on November 26-28, 2024, at Crown Legacy Hotel Kisad Road, Baguio City, with the theme "*DepEd NEU: Kabalikatan sa Pagsusulong ng Five-Point Agenda' ng Kagawaran ng Edukasyon.*"
2. A registration fee of P5,950.00 per participant will be charged to cover expenses for food, lodging, kits, honoraria of resource persons and facilitators, and other incidental expenses. This amount is chargeable to **local funds**, subject to accounting and auditing rules and regulations. The registration fee shall be paid in cash, check, or LDDAP-ADA and deposited directly into the DepEd-NEU National Account at Land Bank of the Philippines (Account Name: DEPED NATIONAL EMPLOYEES UNION No. 3341-0185-94). Accommodation at the Crown Legacy Hotel will be prioritized for those who have registered online and paid the registration fee in full.
4. All participants, including all members of different committees such as NBOT and NEO, are required to pay the registration fee. They may claim travel allowances two days prior to the start of the activity for advance preparation. Registration will begin upon the issuance of this memorandum and will end on Nov. 22, 2024. 3. All participants from the regional office and division office shall ensure the Travel Authority duly approved by the Regional Director and Schools Division Superintendents.
