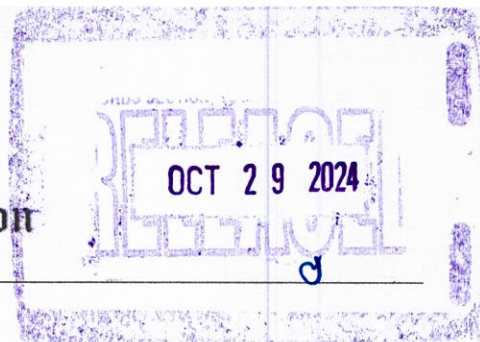

CONDUCT OF NATIONAL COMPETENCY ASSESSMENT (TM1-COC2)
FOR THE SHS-TVL TEACHERS

1. The Surigao del Sur Provincial Office of the Technical Education and Skills Development Authority (TESDA) will conduct the *National Assessment in Trainers Methodology 1, Certificate of Competency* (TM – COC2) on October 29 -30, 2024 at Marihatag, Surigao del Sur.
2. The assessment aims to:
 - a. evaluate the competence of teachers in alignment with TESDA's standards for Certificate of Competency 2, and
 - b. ensure teachers demonstrate the necessary skills, knowledge, and attitudes required for successful performance in their field.
3. Attached is the list of participants from Bislig City and Surigao del Sur divisions who have completed the five-day (5) day of training (Online and the Institutional Assessment) in Trainers Methodology 1, COC2.
