CHANGE OF SCHEDULE AND VENUE: PROGRAM IMPLEMENTATION REVIEW
ON KHAN ACADEMY IMPLEMENTATION IN CARAGA REGION

1. This Regional Memorandum serves to inform all concerned of the venue and change in schedule for the Program Implementation Review (PIR) titled "**Empowering Classrooms Through Data: A Review of Khan Academy Implementation in Caraga Region**" as announced in Regional Memorandum No. 1246, s. 2025.
2. The PIR is **rescheduled from December 9-11, 2025 to December 10-13, 2025**. The revised schedule is as follows:

In consideration of the activity extending to **Saturday, December 13, 2025**, teaching personnel participating on this date shall be granted **Service Credits** in accordance with DepEd Order No. 53, s. 2023, while non-teaching personnel shall receive **Compensatory Time Off (CTO)** in accordance with CSC-DBM Joint Circular No. 2, s. 2004.
