COMPLETION OF POST-TEST COURSE CHALLENGE AND GROWTH MINDSET
POST-TESTS FOR KHAN ACADEMY IMPLEMENTING TEACHERS

1. The Department of Education (DepEd) Caraga Region, through the Curriculum and Learning Management Division (CLMD), announces the required completion of the **Post-Test Course Challenge and Growth Mindset Post-Tests** for all Khan Academy Implementing Teachers participating in the pilot program.

 - a. assess teacher progress and understanding after completing the Pre-Test Course Challenge;
 - b. evaluate growth mindset development among participating students;
 - c. gather necessary data to support the continuation of participants in the Khan Academy Philippines pilot program; and

Students must complete both the Course Challenge Post-Test and Growth Mindset Post-Test by March 31, 2025, to remain part of the pilot program.

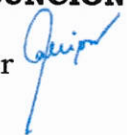
