REGIONAL CONSULTATIVE AND ADVISORY BODY (CAB) SESSION &
WORKSHOP: TEN-YEAR IPED PROGRAM ASSESSMENT (PART 2)

1. The Department of Education (DepEd), through the Curriculum and Learning Management Division (CLMD), will conduct a Regional Consultative and Advisory Body (CAB) Session & Workshop: Ten-Year IPed Program Assessment (Part 2) on July 10–11, 2025, at the Silver Hall, DepEd Regional Office, JP Rosales Avenue, Butuan City.
2. The activity aims to further evaluate the 10-year implementation of the IPed Program, building on insights and recommendations from the previous session to guide future improvements.
3. Expected participants include Division IPed Focal Persons, Division Partnership or Monitoring and Evaluation (M&E) Coordinators, as well as members of the Regional and Division Consultative Advisory Bodies (CAB).
4. All participants are expected to arrive no later than 8:00 a.m. on July 10, 2025, to ensure timely attendance at the opening program. Participants coming from distant divisions may avail themselves of dormitory accommodations on the evening of July 9, 2025; however, meals will not be provided on that day. The first meal will be breakfast on July 10, and the last will be afternoon snacks on July 11, 2025.
5. The venue rental, as well as the food and accommodation of participants, shall be charged to the 2024 Regional IPed Program Support Fund (PSF). This fund will also cover the honoraria and travel expenses of the Consultative Advisory Body (CAB) members. Meanwhile, the travel expenses of IPed focal persons shall be charged to their respective Division IPed PSF, subject to the usual accounting and auditing rules and regulations.
