1. Pursuant to the Department of Education's continuous efforts to promote cultural appreciation, inclusivity, and the preservation of Indigenous Peoples' (IP) traditions through sports, the Department of Education Caraga Region will participate in the **Philippine Sports Commission on the Indigenous People (IP) Games** to be held on **October 10-12, 2025**, in **Buenavista, Agusan del Norte**.

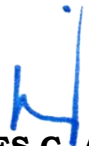
