2. Participants must bring photocopy of their travel authority to receive the certificates of participation and appearance. Travelling expenses, per diem and other allowable expenses that they may incur are still charged against their local funds subject to the usual accounting and auditing rules and regulations.

3. In the morning of February 1, 2019, all non-participants to the slogan-poster making and best recycled product contests are invited to join in the beach games. The participants will not be grouped per division but be based on the actual number present.

4. In the best recycled product contest, be clarified that only the students are allowed to make the products, either Junior HS or Senior HS students or a team of both with no specific number of students required. Participants should bring their own recycled materials ready for assemble during the contest proper and may also opt to present a finished product with multiple designs. No teachers, chaperones or coaches allowed to interfere during the competition.

5. Be informed further that the resort will provide free transport from DepEd lobby to the venue at 7:00 in the morning. The buses will leave once fully occupied.

6. For emergency preparedness, each division is required to bring a first-aid kit and other helpful medical supplies especially during travels back and forth and while the activities are on-going. The school must secure full parents' consent and ensure safety of their students at all times.

III. Best Recycled Products

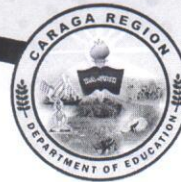
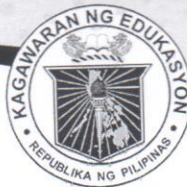
1. Only one (1) kind of product is allowed per Division.
2. The product can be reproduced in many variation (color, design, length, weight, etc.)
3. Makers of the products are the students themselves (JHS/SHS or both).
4. The product must be made in actual for 4 hours (7:00-11:00am).
5. The finished products will be displayed during the awarding of winners.
6. Winners for the 1st-3rd Places will be announced and awarded with plaques. Other participants will be given with certificate of recognition.
7. Decision of the judges is final and non-appealable.
8. Criteria of judging are as follows:

IV. Slogan-Poster Making

1. Only one (1) contestant is allowed per Division.
2. Contestants are bonafide JHS students of any DepEd Caraga Public Schools.
3. Contestants are either a male or a female from Grades 7-10.
4. The poster must revolve around the ASEAN-DRR Context.
5. Entries should be drawn on the spot and the contestants should bring their own materials and supplies: 20"x30" illustration board as canvass with the name of the participant and the school/division pasted on the back of the board, basic drawing and coloring materials limited to crayons, oil pastels, coloring pencils, water color, poster paints and markers;
6. Participants are given a maximum of three (8:00-11:00am) hours to work on the entries. The artwork shall follow the PORTRAIT orientation. No text or mark identifying the participant should appear on the artwork.

CONTESTS MECHANICS AND CRITERIA

I. Spoken Poetry

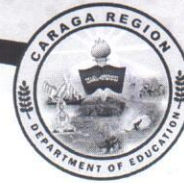
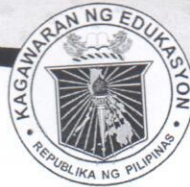
1. Only one (1) contestant is allowed per Division.
2. Contestants are bonafide SHS Students of any DepEd Caraga public schools.
3. The piece may be in English or Filipino or a combination of both.
4. The spoken word piece must be performed live for a maximum of 3 minutes only. A timer will automatically ring signifying the end of the performance whether finished or not.
5. The piece must be submitted in triplicate copies to the panel of judges before the actual performance with the name of the student, school and division represented written at the back.
6. The theme must revolve around ASEAN-DRR issues and concerns.
7. Winners for the 1st-3rd Places will be announced and awarded with plaques. Other participants will be given with certificate of recognition.
8. Decision of the judges is final and non-appealable.
9. Criteria of judging are as follows:

Content (Focus, adherence interest, composition and thought interest)	-	25%
Literary technique (Poetic structure/Text meanings)	-	25%
Conventions (Vocabulary/Grammar)	-	25%
Performance: Interpretation quality (costume, voice, tone, charisma, movement, communication, personality, confidence, mastery, pronunciation, articulation, etc.)	-	25%

II. ASEAN-DRR Youth Model

1. Only one (1) contestant is allowed per Division.
2. Contestants are bonafide JHS students of any DepEd Caraga Public Schools.
3. Contestants are either a male or a female from Grades 7-10.
4. A copy of the brief background of the contestant is to be submitted to the panel of judges before the actual selection. The brief back ground of the contestant must be summarized to include the family background, school academic performance, involvement in ASEAN/DRR and other non-curriculum activities, community participation, etc. supported with pictures of the MOVs.
5. Pictures taken should be clear and colored. No actual MOVs are required on-hand. The document should be printed using A4 Coupon bond paper covered with a sliding plastic folder with cover page containing the name of the competition, name of student, school and division.
6. The said document must be submitted on day 1, **January 31, 2019** to the Secretariat for pre-screening.
7. Contestants must wear an ASEAN-inspired costume during the actual search and awarding of the winners.





7. The contestants will be informed of the time remaining to end the contest.
8. Entries will be displayed for judging during the awarding program.
9. Winners for the 1st-3rd Places will be announced and awarded with plaques. Other participants will be given with certificate of recognition.
10. Decision of the judges is final and non-appealable.
11. Criteria of judging are as follows:

Overall presentation (creativity, color harmony, etc.)	-	50%
Relevance to ASEAN-DRR	-	40%
Originality	-	10%
