NATIONAL IMPLEMENTATION OF LEARNER RIGHTS AND
PROTECTION ON WHEELS 2025

1. Pursuant to the Memorandum DM-OUOPS-2025-11-00861 dated February 28, 2025 from Asec. Malcolm S. Garma, Officer-In-Charge, Office of the Undersecretary for Operations, announcing the **“Learner Rights and Protection (LRP) on Wheels Program”** as an Awareness Campaign Program that brings learner protection services to schools.
2. This program aims to promote awareness on the rights and protection of learners in school through a motorcade, a mascot, and the distribution of advocacy materials. The campaign will include half-day sessions/discussions on bullying, anti-sexual abuse or exploitation of children (OSAEC), anti-child sexual abuse or Exploitation Materials (CSAEM) and abuse reporting.
3. In line with this, all Schools Division Offices (SDOs) are directed to **identify one school** to implement the activity in support of the LRP on Wheels **between July and August 2025**, and to submit an activity report thereafter.
4. Program Support Funds are being allocated to the 12 concerned Schools Division Offices (SDOs) to support this activity.
5. To ensure the effective implementation of the initiative and extend technical assistance, the Regional Learner Rights and Protection Office (LRPO) shall conduct monitoring visits to all divisions during the rollout period.
6. All public and private schools are also enjoined to display banners at their school entrances or other visible areas using designs from these links: <https://tinyurl.com/LRPDESK-TARP>, <https://tinyurl.com/MH-Tarp-Design>, and tinyurl.com/LRPWheels, and conduct classroom-based orientations covering the following topics through panel discussions, art-based activities, roleplays, and simulations:
 - a. How to spot the “Red Flags” of Bullying
 - b. Anti-OSAEC and Anti-CSAEM: Safer Internet Practices for Learners
 - c. Empowering Learners to Report Learner Rights and Protection Abuse (LRP) Cases to Learners Helpline and Other Support Services
