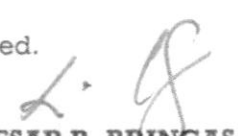

However, travelling expenses of all participants, management staff/QAME, POA shall be charged against MOOE/Local Funds subject to the usual accounting and auditing rules and regulations.
