1. This office hereby informs the field on the conduct of ocular inspection to DepEd schools applying for establishments of Public Schools in IP communities in Agusan del Sur Division.
2. The Division Monitoring and Evaluation (M & E) team members including the IP coordinator are advised to go with the Regional Inspectorate Team (RIT) for the said inspection of each school applicants. However, in order to facilitate the conduct of validation of documentary requirements by the RIT to those school applicants that cannot be reached by the said Division and Regional Inspectorate Teams, the Public School District Supervisors (PSDS), School Heads or School Coordinator shall facilitate to gather all stakeholders or participants in one venue within the District premises which is accessible to convene. Moreover, the School Heads or School Coordinator shall prepare and present to the RIT the updated documents and actual situation of the said schools through video and power point presentation.
3. The presentation for school applicants shall be as detailed as possible following the checklist for application.
4. The Regional Inspectorate Team are assigned on the different areas for M & E on the school's readiness in the establishment of Public School in IP communities, to wit:
