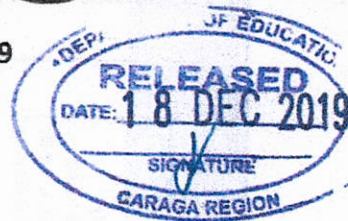

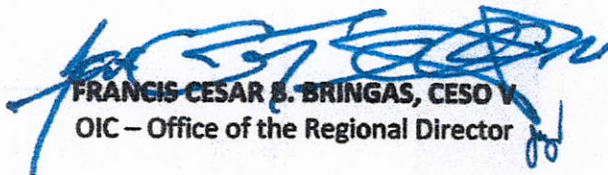
CONDUCT OF DEPED COMPUTERIZATION PROGRAM MONITORING/SPOT CHECKING
